

Rules and Regulations – Christmas Candy Guess To Win Contest

1. How to Enter:

An official entry form may be purchased for \$20.00 at participating locations/merchants or from Ladysmith Chamber of Commerce (“LCOC”) Board or Staff Members. Entry forms must include your name, phone number, email address and your guess at the number of candies.

2. Contest Period:

The Ladysmith Chamber of Commerce Christmas Candy Guess to Win Contest (“Contest”) runs from Monday, November 16th, 2015 to Wednesday, December 16th, 2015. Winners will be announced at the Ladysmith Chamber of Commerce Christmas Membership Social between 5:00 and 7:00 pm on December 16th, 2015.

3. Eligibility

The Contest is open to all Canadian residents who have reached the age of majority in their province or territory of residence at the time of entry. Employees of the Ladysmith Chamber of Commerce and their immediate families (father/mother, brother/sister, son/daughter) or persons living under the same roof with them are not eligible to enter this contest.

4. Procedure for Awarding Prizes

Contest entry forms along with Candy containers will be collected by LCOC staff. Number of candies in the Candy containers will be verified by LCOC staff and a representative of the accounting firm Palmer Leslie Chartered Accountants. Entry forms will be analyzed to determine which entry forms come closest to the actual number of candies in the containers. Prizes will be awarded as follows:

- a) Contestant getting closest to correct number wins the WestJet Getaway Package.
- b) Contestant getting 2nd closest to the correct number wins the Oak Bay Marine Group Getaway Package.
- c) Contestant getting 3rd closest to the correct number wins the Yellow Point Lodge Getaway Package.
- d) Contestant getting 4th closest to the correct number wins the 49th Parallel Holiday Feast Package.

In the event of a tie, the tied contestants will guess at another candy jar (by providing a written guess). The contestant getting closest will receive the first available prize and the contestant(s) getting the next closest will receive the next available prize (if any). Example 1: Contestant A and Contestant B tie for the closest to the correct number of candies in the original container. They are asked to guess at a second container of candies. Contestant B gets closest to the correct number in the second container and receives the WestJet Getaway and Contestant A receives the Oak Bay Marine Group Getaway. Example B: Three contestants (A,B and C) tie for the 4th closest to the correct number of candies in the original container. They are asked to guess at a second container of candies. Contestant B guesses closest to the correct number in the second container and wins the 49th Parallel Holiday Feast. Contestants A and C win nothing.

5. Description of Prizes

a) 1st Prize – WestJet Vacation Getaway

Donated by WestJet Airlines this package includes one return trip for two people to any scheduled WestJet destination (charters exempt). Some restrictions apply: (1) The voucher includes all air travel fees, taxes and surcharges and is valid on WestJet flights only, not valid for flights on or continued on WestJet's code share partners. (2) All gifts of flight are subject to promotional space availability at the time of booking. Peak dates such as statutory holidays and airline blackout periods (such as Christmas, Easter, long weekends and spring break etc.) are considered blackout periods and aren't available for gifts of flight. (3) Flights must be round trip. Open jaw bookings are not permitted. Flights must depart from city A to city B and return from city B to City A. (4) This prize is valid until **December 16th, 2016**. (5) This prize is not valid for redemption on WestJet Vacations' packages or with WestJet charter or code share partners. (6) Changes and extensions to the expiry date are not permitted. Changes to travel dates or passenger names are not permitted once a booking has been confirmed. (7) The individual booking the flight must be over the age of majority in their province. (8) This prize must be taken as offered and is neither transferable nor redeemable for cash. (9) This prize cannot be sold. In the event that it is, this certificate will become void. (10) WestJet is not responsible for lost or mishandled vouchers.

b) 2nd Prize – Oak Bay Marine Group Vacation Getaway

Donated by the Oak Bay Marine Group this package includes 2 nights' accommodation in a standard oceanview suite at Painter's Lodge or April Point Resort & Spa including a 3 hour Wildlife Adventure Tour for two people. Excludes July & August bookings and expires at end of season 2016. The package also includes a 4 hour Wildlife Tour for two.

c) 3rd Prize – Yellow Point Lodge Vacation Getaway

Donated by Yellow Point Lodge this package includes two nights for two people at Yellow Point Lodge in their 'top of the line' Penthouse Suite. The package also includes three meals per person each day, three extra 'tea times' with homemade goodies, and full use of all recreational facilities including bicycles, tennis equipment and kayaks. Some restrictions apply and contestant winner will need to call Yellow Point Lodge directly, which is heavily reserved, to arrange your stay.

d) 4th Prize – 49th Parallel Grocery Holiday Feast

Donated by 49th Parallel Grocery the Holiday Feast includes a \$200 Gift Certificate to purchase all of the menu items you'll need for your holiday celebrations.

6. General Rules

- a) By entering the Contest, each entrant agrees to abide by these Contest Rules. This contest is subject to all applicable federal, provincial, and municipal laws. The decisions of the LCOC with respect to all aspects of this Contest are final and binding on all entrants without right of appeal.

- b) LCOC reserves the right to cancel, suspend, withdraw or amend this Contest in any way, without prior notice or obligation, in the event of an error, technical problem, tampering, unauthorized intervention, fraud, technical failure or any other cause beyond the reasonable control of the LCOC that interferes with the proper conduct of this Contest as contemplated by these Contest Rules. Any attempt to deliberately undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made, the LCOC reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.
- c) All Entries are subject to verification. The LCOC reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification) for the purposes of eligibility and/or legitimacy of any entrant. Contest winners shall sign a release declaring his/her eligibility as stipulated in Section 3 of these rules and releasing LCOC as well as its respective directors, officers and employees from all liability for any damage or loss arising from participation in this Contest or from awarding, acceptance or use of the prize.
- d) Prizes shall be accepted as is and may not be exchanged or refunded for an amount of money, sold or transferred. No substitutions will be allowed. Any unused portion of a prize will be forfeited.
- e) All personal information, such as name and contact information, is collected by LCOC solely for the purposes of administering this Contest and shall not be used for any other purposes.
- f) Odds of winning depend on the total number of entrants. A maximum of 1000 entrants will be sold. If the Contest is sold out, odds of winning are 1 in 250.
